### About the CPA

The Certified Public Accountant (CPA) designation distinguishes licensed accounting professionals as one of the leading financial accounting qualifications in the Middle East.

The CPA exam is set by the American Institute of Certified Public Accountants (AICPA) and administered by the National Board of State Boards of Accountancy (NASBA). Its credential is a license issued by one of the 55 State Boards of Accountancy in the United States of America, and this can now be studied and examined outside the United States.

The AICPA has nearly **418,000** in **143** countries, including CPAs in business and industry, public accounting, government, education, student affiliates and international associates.

Whether you're looking to begin your career in accounting or enhance your financial advisory skills to prepare for a career upgrade, then CPA is the right choice for you.



## Getting qualified



To obtain the CPA designation, you are expected to meet the eligibility requirement which is issued by one of the US State Boards of Accountancy.

As each State Board of Accountancy has different requirements which must be met in order to be eligible to undertake the CPA qualification.

### Minimum entry requirements

- A bachelor's degree in accounting, finance or business with 120 credits
- A minimum of 120 credit hours to be eligible to take the CPA exams
- A minimum of 150 credit hours and 1-2 years work experience to apply for a CPA license

### The CPA journey

You can sit for the exams in any order. However from the date of passing your first exam you must take and pass all 4 exams within 18 months.

The training programme can be completed between 12 -18 months. This takes into account the time taken to get your credentials verified as each state's requirements may vary.

### CPA consists of four sections, each has its own exam:

Auditing and Attestation (AUD)

Business Environment and Concepts (BEC)

Financial Accounting and Reporting (FAR)

Regulation (REG)

### What to expect from the exam?

- The CPA exams are made up of a mixture if MCQ's, task based simulations and written questions
- The pass mark for the CPA exams is 75%
- The exams can be taken at authorised test centres in Bahrain. Kuwait. Lebanon and the UAE
- As part of PwC's Academy training, you will get the opportunity to take several mock exams in an environment stimulating the real examination in order to prepare you not only technically, but psychologically as well

As of 1 July 2020, testing windows will be replaced by continuous testing, allowing you to take the exam all year-round.


