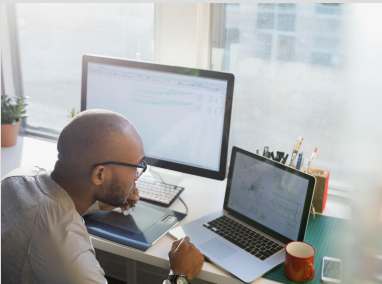

Who is it for?

PMP is suitable for any experienced project manager responsible for all aspects of project delivery, leading and directing cross-functional teams; regardless of the industry.

Eligibility criteria

In order to qualify for the PMP examination candidates should meet the following eligibility criteria:

- A four-year degree
- 36 months leading projects
- 35 hours of project management education/training or CAPM qualification

OR

- A high school diploma or an associate's degree (or global equivalent)
- 60 months leading projects
- 35 hours of project management education/training or CAPM Certification

Examination

In order to receive the PMP certification, candidates must complete 35 contact hours in classroom teaching and pass the exam at one of PMI's exam centers. The exam consists of a 180-question in a multiple choice format.

Exam fees:

Members: USD 405

Non-members: USD 555
